
IN THE NAME AND BY THE AUTHORITY OF THE STATE OF IOWA

PROCLAMATION OF DISASTER EMERGENCY

- WHEREAS,** ON SUNDAY, MAY 25, 2008 AND CONTINUING, SEVERE STORM SYSTEMS MOVED ACROSS LINN COUNTY; AND
- WHEREAS,** STORMS HAVE RESULTED IN WIDESPREAD FLOODING AND DESTRUCTION TO LINN COUNTY; AND
- WHEREAS,** PURSUANT TO SECTIONS 425.2, 425.15 AND 426A.13 OF THE IOWA CODE, TAXPAYERS IN LINN COUNTY NORMALLY MUST APPLY FOR HOMESTEAD CREDITS, DISABLED VETERAN CREDITS AND MILITARY SERVICE TAX CREDITS RELATED TO PROPERTY TAX WITH THE LINN COUNTY ASSESSOR AND CEDAR RAPIDS ASSESSOR BY JULY 1, 2008; AND
- WHEREAS,** MANY TAXPAYERS WILL BE UNABLE TO FILE APPLICATIONS FOR THESE PROPERTY TAX CREDITS BY JULY 1, 2008 DUE TO THESE UNPRECEDENTED FLOODS AND DESTRUCTION:

NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, BY THE POWER AND AUTHORITY VESTED IN ME BY THE CONSTITUTION ARTICLE IV, SECTIONS 1 AND 8 AND IOWA CODE SECTION 29C.6(1), DO HEREBY DECLARE THE FOLLOWING MEASURES:


1. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY EXTEND THE DEADLINE FOR TAXPAYERS IN LINN COUNTY AFFECTED BY FLOODING AND HAVE APPLICATIONS FOR THESE PROPERTY TAX CREDITS DUE TO THE LINN COUNTY ASSESSOR AND CEDAR RAPIDS ASSESSOR BY JULY 1, 2008.
2. APPLICATIONS FOR THESE PROPERTY TAX CREDITS TO THE LINN COUNTY ASSESSOR AND CEDAR RAPIDS ASSESSOR FOR TAXPAYERS IN LINN COUNTY AFFECTED BY FLOODING WILL NOT BE DUE UNTIL JULY 31, 2008.
3. THIS EMERGENCY DECLARATION IS EFFECTIVE IMMEDIATELY.
