PROCLAMATION OF DISASTER EMERGENCY SECOND EXTENSION

WHEREAS, ON SUNDAY MAY 25, 2008 AND CONTINUING, SEVERE STORM SYSTEMS

MOVED ACROSS PORTIONS OF IOWA; AND

WHEREAS, THIS STORM SYSTEM SPAWNED SEVERE WEATHER TO INCLUDE

TORNADOES, HEAVY RAINS, WIND, HAIL, AND SEVERE

THUNDERSTORMS CAUSING SEVERE DAMAGES, FLOODING AND RELATED IMPACTS TO PRIVATE AND PUBLIC PROPERTY INCLUDING RESIDENCES, BUSINESSES, INFRASTRUCTURE, AND AGRICULTURE;



NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, DO HEREBY PROCLAIM A STATE OF DISASTER EMERGENCY TO BE EXTENDED FOR THE COUNTIES LISTED ABOVE UNTIL AUGUST 22, 2008. THIS PROCLAMATION OF DISASTER EMERGENCY AUTHORIZES LOCAL AND STATE GOVERNMENT TO RENDER GOODS AND SUFFICIENT AID TO ASSIST THOSE AREAS IN THIS TIME OF NEED.
