
PROCLAMATION OF DISASTER EMERGENCY

- WHEREAS,** ON TUESDAY, DECEMBER 22, 2009 A SEVERE WINTER STORM SYSTEM MOVED ACROSS PORTIONS OF IOWA; AND
- WHEREAS,** THIS STORM SYSTEM SPAWNED FREEZING RAIN, HEAVY SNOW AND BLIZZARD CONDITIONS, CAUSING DAMAGES AND RELATED IMPACTS TO PRIVATE AND PUBLIC INFRASTRUCTURE; AND
- WHEREAS,** ON DECEMBER 28, 2009 I ISSUED MY PROCLAMATION OF DISASTER FOR HARRISON, POTTAWATTAMIE AND SHELBY COUNTIES; AND
- WHEREAS,** ON DECEMBER 29, 2009 I ISSUED MY PROCLAMATION OF DISASTER FOR CRAWFORD COUNTY; AND
- WHEREAS,** ON DECEMBER 30, 2009 I ISSUED MY PROCLAMATION OF DISASTER FOR AUDUBON, MILLS AND MONONA COUNTIES; AND
- WHEREAS,** LOCAL OFFICIALS IMPACTED BY THE SEVERE WEATHER NEED ASSISTANCE WITH EMERGENCY SNOW REMOVAL FROM COUNTY ROADS; AND
- WHEREAS,** STATE ASSISTANCE WILL BE NEEDED TO MINIMIZE THE HARDSHIP AND RECOVER FROM THE IMPACTS OF THIS STORM:


NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, DO HEREBY PROCLAIM A STATE OF DISASTER EMERGENCY TO BE EXTENDED FOR THE COUNTIES LISTED ABOVE UNTIL FEBRUARY 24, 2010. THIS PROCLAMATION OF DISASTER EMERGENCY AUTHORIZES LOCAL AND STATE GOVERNMENT TO RENDER GOODS AND SUFFICIENT AID TO ASSIST THOSE AREAS IN THIS TIME OF NEED.



IN TESTIMONY WHEREOF, I HAVE HERE-UNTO SUBSCRIBED MY NAME AND CAUSED THE GREAT SEAL OF THE STATE OF IOWA TO BE AFFIXED. DONE AT DES MOINES THIS 25TH DAY OF JANUARY IN THE YEAR OF OUR LORD TWO THOUSAND TEN.
