IN THE NAME AND BY THE AUTHORITY OF THE STATE OF IOWA

PROCLAMATION OF DISASTER EMERGENCY

- WHEREAS,** ON TUESDAY JUNE 1, 2010 AND CONTINUING, SEVERE STORM SYSTEMS MOVED ACROSS PORTIONS OF IOWA; AND
- WHEREAS,** STORMS HAVE RESULTED IN WIDESPREAD FLOODING AND DESTRUCTION TO AREAS IN IOWA; AND
- WHEREAS,** THE FOLLOWING FORTY-SEVEN (47) COUNTIES HAVE BEEN DECLARED DISASTER AREAS (DISASTER COUNTIES) AS A RESULT OF SAID STORMS: APPANOOSE, BLACK HAWK, BUCHANAN, BUENA VISTA, BUTLER, CHEROKEE, CLAY, CLAYTON, DAVIS, DECATUR, DELAWARE, DICKINSON, DUBUQUE, EMMET, FAYETTE, FRANKLIN, HAMILTON, HANCOCK, HOWARD, HUMBOLDT, JACKSON, JASPER, JEFFERSON, JOHNSON, JONES, KOSSUTH, LEE, LUCAS, LYON, MAHASKA, MARION, MONROE, O'BRIEN, OSCEOLA, PALO ALTO, POLK, RINGGOLD, SHELBY, SIOUX, TAYLOR, UNION, VAN BUREN, WAPELLO, WARREN, WASHINGTON, WEBSTER, AND WRIGHT; AND
- WHEREAS,** THE FLOODING AND DESTRUCTION HAVE RESULTED IN THE LOSS OF LICENSES AND OTHER IMPORTANT DOCUMENTS ISSUED TO IOWANS BY THE STATE OF IOWA; AND
- WHEREAS,** STRICT COMPLIANCE WITH THOSE PROVISIONS OF THE IOWA CODE IMPOSING FEES FOR OBTAINING REPLACEMENT DOCUMENTS AND CERTIFICATES ISSUED BY THE STATE OF IOWA WILL BE AN ADDITIONAL EXPENSE AND HARDSHIP TO PERSONS WHO HAVE SUFFERED LOSSES AND DAMAGES AS A RESULT OF SAID FLOODS AND STORMS, AND WILL PREVENT, HINDER OR DELAY REPLACEMENTS OF THOSE NECESSARY DOCUMENTS AND ITEMS; AND
- WHEREAS,** REPLACEMENT OF DOCUMENTS ISSUED BY THE STATE OF IOWA THAT WERE DAMAGED OR DESTROYED IN SAID FLOODS AND STORMS IS NECESSARY TO COPE WITH THE EMERGENCY POSTED BY SAID FLOODS AND STORMS; AND
- WHEREAS,** NUMEROUS SNOWMOBILES, ALL-TERRAIN VEHICLES, AND VESSELS HAVE BEEN DAMAGED AND DESTROYED IN SAID COUNTIES AS A RESULT OF SAID FLOODS AND STORMS; AND WILL REQUIRE REPAIR, SALVAGE, DEMOLITION, OR OTHER REMEDIAL ACTION REQUIRING PROOF OF OWNERSHIP; AND
- WHEREAS,** THE REGISTRATION DOCUMENTS FOR MANY OF THESE SNOWMOBILES, ALL-TERRAIN VEHICLES AND VESSELS, AS WELL AS LICENSES RELATED TO HUNTING AND FISHING LICENSES AND HUNTER EDUCATION CERTIFICATION, WERE LOST, MADE ILLEGIBLE OR DESTROYED AS A RESULT OF SAID FLOODS AND STORMS; AND
- WHEREAS,** STRICT COMPLIANCE WITH THOSE PROVISIONS OF THE IOWA CODE IMPOSING FEES FOR OBTAINING REPLACEMENT REGISTRATION DOCUMENTS AND CERTIFICATES WILL BE AN ADDITIONAL EXPENSE AND HARDSHIP TO PERSONS WHO HAVE SUFFERED LOSSES AND DAMAGES AS A RESULT OF SAID FLOODS AND STORMS, AND WILL PREVENT, HINDER OR DELAY REPLACEMENT OF THOSE NECESSARY DOCUMENTS AND ITEMS; AND
- WHEREAS,** REPLACEMENT OF REGISTRATION, TITLING AND LICENSURE DOCUMENTS DAMAGED OR DESTROYED IN SAID FLOODS AND STORMS IS NECESSARY TO COPE WITH THE EMERGENCY POSED BY SAID FLOODS AND STORMS:

NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, BY THE POWER AND AUTHORITY VESTED IN ME BY THE CONSTITUTION ARTICLE IV, SECTIONS 1 AND 8 AND IOWA CODE SECTION 29C.6(1), DO HEREBY DECLARE THE FOLLOWING MEASURES:

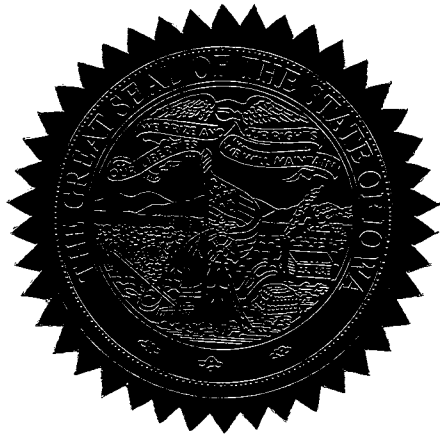
1. PURSUANT TO IOWA CODE SECTION 29C.6 (6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 144.46 PRESCRIBING A FEE FOR ISSUANCE OF THE FOLLOWING: A CERTIFIED COPY OR SHORT FORM CERTIFICATION OF A CERTIFICATE OR RECORD; A SEARCH OF THE FILES OR RECORDS WHEN NO COPY IS MADE, OR WHEN NO RECORD IS FOUND ON FILE. THE SUSPENSION IS APPLICABLE TO PERSONS WHOSE ORIGINAL RECORDS WERE LOST OR DESTROYED IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID STORMS. A WRITTEN STATEMENT BY THE PERSON, IN OR APPENDED TO THE PERSON'S APPLICATION FOR REPLACEMENT OF ORIGINAL RECORDS, CONFIRMING THAT THE ORIGINAL RECORDS WERE LOST OR DESTROYED IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION.
2. THE SUSPENSIONS LISTED IN PARAGRAPH "1" ABOVE APPLIES ONLY TO REPLACEMENT COPIES OF ORIGINAL DOCUMENTS ISSUED IN IOWA, AND MAY BE RELIED UPON BY THE STATE REGISTRAR OR ANY OF THE COUNTY REGISTRARS OF ANY OF THE COUNTIES OF IOWA, SO LONG AS THE RESPECTIVE LOSS, DESTRUCTION, OR INELIGIBILITY OCCURRED IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID STORMS.
3. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 321G.6(3) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE REGISTRATIONS FOR SNOWMOBILE REGISTRATIONS IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE REGISTRATION DOCUMENT WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL REGISTERED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.
4. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 321G.30(1) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE CERTIFICATES OF TITLE FOR SNOWMOBILES IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE CERTIFICATE OF TITLE WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL TITLED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.
5. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 321I.7(3) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE REGISTRATIONS FOR ALL-TERRAIN VEHICLE REGISTRATIONS IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE REGISTRATION DOCUMENT WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL REGISTERED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.
6. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 321I.32(1) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE CERTIFICATES OF TITLE FOR ALL-TERRAIN VEHICLE REGISTRATIONS IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE CERTIFICATE OF TITLE WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL TITLED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.
7. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 462A.5(4) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE REGISTRATION CERTIFICATES FOR VESSELS IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE REGISTRATION CERTIFICATE WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL REGISTERED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.
8. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 462A.78(1) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE CERTIFICATE OF TITLE FOR VESSELS IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN STATEMENT BY THE OWNER, IN OR APPENDED TO THE APPLICATION FOR THE SAME, CONFIRMING THAT THE CERTIFICATE

OF TITLE WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS, SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE COUNTY RECORDER IN WHICH THE PROPERTY WAS ORIGINAL TITLED TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION.


9. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 483A.14 PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE LICENSE FOR FISHING AND HUNTING PRIVILEGES IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN AND CERTIFIED STATEMENT BY THE OWNER CONFIRMING THAT THE LICENSE(S) WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS AND PROVIDING REQUISITE INFORMATION TO PROCESS THE REQUEST SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE DEPARTMENT OF NATURAL RESOURCES TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION. PERSONS SEEKING DUPLICATE LICENSES FROM LICENSE AGENTS WHO UTILIZE THE ELECTRONIC LICENSING SYSTEM OF IOWA MAY NOT BE ELIGIBLE FOR A WAIVER UNDER THIS PROCLAMATION.
10. PURSUANT TO IOWA CODE SECTION 29C.6(6), I DO HEREBY SUSPEND THE REGULATORY PROVISIONS OF IOWA CODE SECTION 462A.27(9) PRESCRIBING A FEE FOR ISSUANCE OF A DUPLICATE HUNTER SAFETY CERTIFICATE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS. A WRITTEN AND CERTIFIED STATEMENT MADE BY THE OWNER CONFIRMING THAT THE LICENSE(S) WAS LOST OR MADE ILLEGIBLE IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID FLOODS AND STORMS AND PROVIDING REQUISITE INFORMATION TO PROCESS THE REQUEST SHALL BE REQUIRED TO INVOKE THIS SUSPENSION. PERSONS AFFECTED BY THIS SECTION MUST SUBMIT DOCUMENTATION TO THE DEPARTMENT OF NATURAL RESOURCES TO HAVE THEIR FEES WAIVED UNDER THIS PROCLAMATION. PERSONS SEEKING DUPLICATE LICENSES FROM LICENSE AGENTS WHO UTILIZE THE ELECTRONIC LICENSING SYSTEM OF IOWA MAY NOT BE ELIGIBLE FOR A WAIVER UNDER THIS PROCLAMATION.

THESE SUSPENSIONS APPLY TO ORIGINAL REGISTRATION DOCUMENTS ISSUED IN ANY OF THE COUNTIES OF IOWA, AND MAY BE RELIED UPON BY THE TREASURERS OF ANY OF THE COUNTIES OF IOWA, SO LONG AS THE RESPECTIVE LOSS, DESTRUCTION, OR ILLEGIBILITY OCCURRED IN ANY ONE OF THE DISASTER COUNTIES AS A RESULT OF SAID STORMS.


THE SUSPENSION OF REGULATORY PROVISIONS PURSUANT TO IOWA CODE SECTION 29C.6(6) IN THE IMPACTED COUNTIES, AS SET FORTH ABOVE, SHALL REMAIN IN EFFECT FOR THIRTY DAYS FROM THE DATE OF THIS DECLARATION.
