Visitor parking is available across the street from W-4.



Directions from exit 129 (86th Street exit) coming from the south on I-35:

- To CAMP DODGE MAIN GATE:
Turn RIGHT onto Ramp towards NW 86th St
Turn LEFT (North) onto NW 86th ST
Turn RIGHT (East) onto NW 70th Ave
Turn LEFT into Camp Dodge Main Gate

Directions from exit 131 (Merle Hay Road exit) coming from the north on I-35:

- To CAMP DODGE MAIN GATE:
Turn RIGHT onto Ramp towards Merle Hay Rd
Turn RIGHT (North) onto Merle Hay Rd
Turn LEFT (West) onto NW 70th Ave
Turn RIGHT into Camp Dodge Main Gate
