New “Req-A” IMAC Form Available

The Iowa Mutual Aid Compact, or IMAC, is an intrastate program under Iowa Code 29C.22 that allows local jurisdictions to request or provide assistance in a disaster that has been declared either by the local political subdivision or the Governor. The compact was signed into law April 22, 2002, but legislation amended the compact July 1, 2009, to address membership, include emergency management commissions and designate authorized representatives.

Since the use of IMAC is legally binding and requires written documenta-

tion, the IMAC form or Req-A Form has also been updated to better assist local jurisdictions in capturing necessary information. Some examples of the various changes made to the Req-A Form:

1. Information Text Boxes. When using the form electronically, users can place their mouse over the red triangle located in some cells to see a description or explanation of the content being requested.

In addition to a well rounded planning Workshop, each participant will receive the Authoritative new manual from NFPA which explains how to develop a program in compliance with NFPA 1600. This includes a wealth of useful forms, worksheets, checklists and more.

The NFPA 1600 Standard establishes a common set of criteria for disaster/emergency management and business continuity programs. In addition, the standard provides disaster and emergency management and business continuity programs, the criteria to access current programs or to develop, implement, and maintain aspects for the prevention, mitigation, preparation, response, and recovery from emergencies.

Lt. Col. (Ret.) Dave Grossman will present “*Lessons from Jonesboro, Littleton, and Vietnam: How Kids are Learning to Kill and Learning to Like It.*” Lt. Col. Grossman is one of the world’s leading experts on interpersonal aggression and violence. He was a trainer of health professionals, law enforcement and first responders after the school shootings in Jonesboro, Arkansas; Springfield, Oregon; Littleton, Colorado; West Nickel Mines Amish School, Pennsylvania; and Virginia Tech. Grossman was also called as an expert witness and consultant in U.S. v. Timothy McVeigh and the Paducah school shooting case. He has also testified

before U.S. Senate and House committees. Former psychology professor at West Point and Director of Killology Research Group, Grossman has devoted himself to teaching, writing, speaking and research.
