#### **NEW – Dangerous Prolonged Heat Possible This Week**

#### **NEW – Gov. Branstad Approves Proclamation for State Individual Assistance Grant Program**

Gov. Branstad approved a proclamation last week to enact the State Individual Assistance Grant Program. The program will be made available to Iowa residents living in the flood-affected counties of Woodbury, Monona, Harrison, Pottawattamie, Mills and Fremont.

The State Individual Assistance Grant Program provides grants of up to \$5,000 to families with household incomes at or below twice the federal poverty index. The program is launched with a governor's declaration and at the request of local officials. Applicants must be legal residents of the United States and need to provide all receipts for replacement items claimed.

### **Disaster Assistance Available for Small Businesses**

Small, non-farm businesses in 14 Iowa counties are now eligible to apply for low interest disaster loans from the U. S. Small Business Administration (SBA). Eligible primary counties are Fremont, Harrison, Mills, Monona, Pottawattamie and Woodbury; eligible neighboring counties are Cass, Cherokee, Crawford, Ida, Montgomery, Page, Plymouth and Shelby.

SBA eligibility covers both the flood-related economic impacts on businesses dependent on farmers and ranchers businesses directly impacted by the disaster. Non-farm businesses, agricultural cooperatives, small businesses engaged in aquaculture and most private, non-profit organizations may qualify for Economic Injury Disaster Loans (EIDLs). Businesses primarily engaged in farming or ranching are not eligible for SBA disaster assistance. These enterprises should contact the Farm Services Agency (FSA) about the U. S. Department of Agriculture (USDA) assistance made available by the Secretary’s declaration.

The deadline to apply for these loans is March 8, 2012. Applicants may apply online via SBA’s secure website at <https://disasterloan.sba.gov/ela>. ### **SHELTER SUMMARY – IOWA SHELTERS**

**NEW** - The shelter at the Iowa School for the Deaf in Council Bluffs reported two residents overnight. Numerous shelters remain on standby and are ready to receive residents if needed.

### **STATE RESPONSE SUMMARY**

- **Homeland Security and Emergency Management Division (HSEMD)**
  - HSEMD, along with the Federal Emergency Management Agency (FEMA), Small Business Administration (SBA) and county officials conducted preliminary damage assessments on July 6 in Woodbury, Monona, Harrison, Pottawattamie, Mills and Fremont counties. Information collected during the assessments is being evaluated and will be used to determine if damages that have occurred thus far are sufficient to warrant a request for federal Individual Assistance Program funding.
  - HSEMD Operations staff visited in Fremont, Mills and Pottawattamie counties with the emergency management coordinators, local officials and impacted citizens. Visits to Harrison, Monona and Woodbury counties will be planned.
  - HSEMD continues to work closely with personnel from various local, state, federal, voluntary and faith-based organizations as well as private partners in response to flooding along the Missouri River in western Iowa. HSEMD staff continues to field calls and provide assistance on a 24-hour basis to local emergency management officials.

- The State Emergency Operations Center will be staffed as warranted to respond to requests from impacted counties.
- HSEMD has requested technical assistance from the Army Corps of Engineers for all counties along the Missouri River from Woodbury County south.
- **Iowa Commission on Volunteer Service**
  - Ongoing support of missions assigned, including access to volunteer and AmeriCorps resources.
  - AmeriCorps will be sending three volunteers to Mills County to assist with disaster data collection.
- **Iowa Department of Human Services (DHS)**
  - The DHS Disaster Behavioral Health Response Team (DBHRT) attended town meetings in Missouri Valley and Hamburg.
  - The DBHRT continues to provide assistance in declared counties as requested. For additional information on resources provided by the DBHRT, visit <http://www.iowadbhrt.org/>.
- **Iowa Department of Natural Resources (DNR)**
  - DNR is coordinating technical assistance through the Environmental Protection Agency to work with all six counties in establishing collection sites for household hazardous waste.
  - People who have been evacuated because of flooding along the Missouri River will be able to camp in certain areas of Iowa State Parks without having to pay a camping fee or having to move after 14 consecutive days. Evacuees may call the DNR at 515-281-8004 to check on availability of campsites for long-term use.
  - DNR is providing technical assistance to waste water facilities, water supplies, industry, fuel stations, etc.
  - DNR is supporting a Mid American Energy request for a boat to check on integrity of poles and other items along the river.

- **Iowa Department of Corrections (DOC)**
  - Ongoing support of missions assigned. Continued coordination of inmate crews to assist with sandbagging operations as requested.
  - Inmates continue to provide sandbagging assistance in Mills County.
- **Iowa Department of Transportation (DOT)**
  - The DOT is finishing up their project on I-29 near Blencoe where they are raising the interstate one foot with asphalt.
  - The DOT continues work on building out the edges of Highway 175 near the bridge

- **Iowa Department of Public Safety (DPS)**
  - The DPS continues to provide aerial photography of impacts to affected counties. Areas of focus include surveys of Highway 175 Bridge and anhydrous tanks in support of DOT and IDALS.
  - The DPS continues to monitor roads, road closures and other public safety issues.
  
- **Iowa National Guard (NG)**
  - National Guard is performing levee patrol duties in Mills and Pottawattamie counties.
  - National Guard liaisons are in place in county EOCs.
  - Providing support through Guard Emergency Situational Awareness Contacts in impacted counties.
  
- **Iowa Department of Agriculture and Land Stewardship (IDALS)**
  - Continual monitoring of impacts to agriculture sector.
  
- **Iowa Department of Public Health (DPH)**
  - Continued support in responding to public health concerns that have been raised in impacted counties.
  - Continual monitoring of the situation with this week's added issue of high heat indices.
  - Responding to an inquiry from Pottawattamie County on the need for vaccinations.
  - Working with FEMA on vector monitoring and control issues.

- **Iowa Finance Authority (IFA)**
  - **Foreclosure prevention counseling:** Disaster-impacted homeowners that feel they may begin to struggle with their mortgage payment are encouraged to call Iowa Mortgage Help for free, confidential mortgage counseling. Iowa Mortgage Help does not offer direct financial assistance. - **Woodbury**
  - Levee patrol duties are being performed by the Sioux City Public Works Department and the Sioux City Police Department.

  - FEMA has notified HSEMD and DNR that the request for “technical assistance only” has been approved by the Environmental Protection Agency.
