NEW – Iowa Federal Assistance Denied, Branstad to Appeal
Governor Branstad was notified late yesterday by Federal Emergency Management
Agency Director Craig Fugate that Iowa's request for activation of the Federal Individual
Assistance Program for Fremont, Harrison, Monona, Pottawattamie, and Woodbury
Counties has been denied.

"Obviously I am disappointed for the citizens in the impacted counties that my request was denied," said Gov. Branstad. "However, I intend to appeal this issue with FEMA based on the simple facts that the flood is still occurring and as the waters slowly recede, new damages will be revealed which will have further impacts to lowans already fighting through this unprecedented flooding event."

The appeal of the decision by FEMA will be coordinated by the Iowa Homeland Security and Emergency Management Division (HSEMD). HSEMD Administrator Brigadier General Derek Hill indicated that the Division will be working closely with the local emergency management agencies to determine additional damages and impacts caused by the ongoing flood.

"It is incredibly important to the citizens along the Missouri River that we are successful in this appeal," said Hill. "The aid provided in the Individual Assistance program is a major piece of the puzzle that is needed to help lowans recover from this flood."

It is important that residents in threatened areas remain prepared in case conditions change. Keeping a bag packed with essential items and establishing a family evacuation plan will help lowans be ready to evacuate if an order is given.

**Shelter Summary – Iowa Shelters:** On July 29, the American Red Cross opened a shelter at First Congregational United Church of Christ, 611 First Avenue in Council Bluffs. Numerous shelters remain on standby and are ready to receive residents if needed.
