## PROCLAMATION OF DISASTER EMERGENCY EXTENSION

WHEREAS, ON TUESDAY, JUNE 1, 2010 AND CONTINUING, SEVERE STORM SYSTEMS MOVED

ACROSS PORTIONS OF IOWA; AND

WHEREAS, THESE STORM SYSTEMS SPAWNED SEVERE WEATHER TO INCLUDE

TORNADOES, FLOODING, AND FLASH FLOODING AND RELATED IMPACTS TO PRIVATE AND PUBLIC PROPERTY INCLUDING RESIDENCES AND BUSINESSES;

AND

WHEREAS, ON JUNE 22, 2010 I ISSUED MY PROCLAMATION OF DISASTER FOR FRANKLIN,

HANCOCK, RINGGOLD, TAYLOR, UNION, AND WRIGHT COUNTIES; AND

WHEREAS, ON JUNE 24, 2010 I ISSUED MY PROCLAMATION OF DISASTER FOR DECATUR,

MARION, MONROE AND SIOUX COUNTIES; AND

WHEREAS, ON JUNE 29, 2010 I ISSUED MY PROCLAMATION OF DISASTER FOR BUTLER,

BUENA VISTA, CHEROKEE, CLAY, DAVIS, EMMET, HAMILTON, HOWARD, HUMBOLDT, JEFFERSON, KOSSUTH, LEE, O'BRIEN, OSCEOLA, PALO ALTO, POLK,

VAN BUREN, WAPELLO AND WEBSTER COUNTIES; AND

WHEREAS, ON JULY 15, 2010 I AMENDED MY PROCLAMATION OF DISASTER DATED JUNE 27,

2010 TO AUTHORIZE THE IMPLEMENTATION OF THE STATE INDIVIDUAL ASSISTANCE GRANT PROGRAM FOR MAHASKA AND WARREN COUNTIES; AND

WHEREAS, LOCAL OFFICIALS AND RESIDENTS IMPACTED BY THIS SEVERE WEATHER

CONTINUE TO NEED ASSISTANCE TO DEAL WITH THE IMPACTS OF THESE

STORMS:

NOW, THEREFORE, I, CHESTER J. CULVER, GOVERNOR OF THE STATE OF IOWA, DO HEREBY PROCLAIM A STATE OF DISASTER EMERGENCY TO BE EXTENDED FOR BUENA VISTA, BUTLER, CHEROKEE, CLAY, DAVIS, DECATUR, EMMET, FRANKLIN, HAMILTON, HANCOCK, HOWARD, HUMBOLDT, JEFFERSON, KOSSUTH, LEE, MAHASKA, MARION, MONROE, O'BRIEN, OSCEOLA, PALO ALTO, POLK, RINGGOLD, SIOUX, TAYLOR, UNION, VAN BUREN, WAPELLO, WARREN, WEBSTER AND WRIGHT COUNTIES IN THE STATE OF IOWA UNTIL AUGUST 21, 2010. THIS PROCLAMATION OF DISASTER EMERGENCY AUTHORIZES STATE GOVERNMENTS TO RENDER GOODS AND SUFFICIENT AID TO ASSIST THESE AREAS IN THIS TIME OF NEED; AND AUTHORIZES THE EXTENSION OF THE APPLICATION DEADLINE FOR THE STATE INDIVIDUAL ASSISTANCE GRANT PROGRAM TO ASSIST ELIGIBLE RESIDENTS AND MINIMIZE THEIR HARDSHIP.
