#### **Introductions**

Chair Rob Rotter welcomed everyone. A roll call was conducted by Secretary Cara Sorrells of the board members in attendance. A quorum was not established yet, and the meeting began with Blake DeRouchey's program manager report.

Blake DeRouchey began with a wish for a Happy National Public Safety Telecommunicator Week next week. He appreciates everyone's efforts and encourages people to follow APCO/NENA/NASNA on social media as they will most likely have some good content that you can share with your stakeholders. Follow them and help get the word out that it is public safety telecommunicator week next week.

Next was an update on legislation as of the time of his report. The per diem for this session ends next Tuesday and they are very close to wrapping up. Things are moving fast and changing quickly. There are two bills for the boards and commissions in reference to the 911 Council. SF 2385 passed the Senate yesterday and that current version of legislation would eliminate the 911 Council. HF2574 currently would leave the 911 Council in place, so at some point the two Chambers are going to have to agree and come to an amendment or compromise. In regard to School Safety bill HF2652, which has passed the House, that proposes to use \$3 million dollars of 911 surcharge funds for a program to implement weapons detector software at schools. That program currently would be housed within their department at Homeland Security and Emergency Management. It would not be a 911 specific program. That has been passed by the House now for over a month and the Senate has not done much with it. In the final hours of the session as compromises are made if it does move it will likely move quickly and is something to pay attention to. Additionally, a bill that was signed yesterday by the Governor was a DPS bill increasing penalties for swatting calls.

The posting for the open position of Program Planner closed last week. Allie Bright has been promoted within the department to Public Information Officer. They are reviewing the candidates and will be having interviews in the upcoming days. They hope to decide and an announcement by the next Council meeting in May. They will send out an email as well.

A number of years ago they sent information out that you are able to transfer text to 911 calls within the state. DeRouchey hoped that everyone was aware of and remembered that. If not, he is happy to share that information with you. An update is that now interstate text to 911 transfers are available. Primarily, you are going to be using this if you are one of the border counties in Iowa. It is the same states that we are able to transfer 911 calls, which is all of the border states except Wisconsin, at this point. It is the same methodology that we use, it's a pound sign and then using the FCC ID to transfer to your adjacent counties in a different state. If you are a border county, you would have received that email, but they want to make sure everyone's aware that this is now a capability.

In March they did submit the FY '21-22 biannual expenditure report to the legislature. The State Auditor's office produced their report as well. The audit continues to hit upon the importance of retaining your methodology for how you came up with the numbers that you submit on your PSAP expenditure report. So, you need to keep your source materials for how you arrive at your final figures. Understanding that a lot of times there are transitions at PSAPs, so make sure that binder sits on the shelf and doesn't walk out the door when there is a transition in leadership. The expenditure report is on their website and let them know if you have any questions.

For this current reporting cycle, they did have to send out three notices regarding late expenditure collection forms for the 2023 fiscal year. Those are legally due to their office by March 31st. Three counties were late in submitting those, however, after sending the notification they received all three within the same week the first week of April. Because the surcharge checks are not sent until later in the month of April, those three counties will still receive their full funding. It was basically just a letter, and will probably be noted on the audit when those get submitted a year and a half from now. They are still missing (3) service board membership forms as well. Those counties are listed on his slide above (Fremont, Grundy, and Hardin).

Comtech did a rather large NexGen 911 core service upgrade a couple of weeks ago. There are a couple of benefits from that for you at the PSAP. Blake is contacted often from counties asking who their backup PSAPs are. With this upgrade, you will soon be able to look up who your provisioned call routing alternatives are yourself. It will be similar to some of the other Comtech logins that PSAPs have access to. You can see who your backups are and submit changes as well. Real-time text will be another future enhancement. We currently have text to 911, but with real-time text you will literally see the characters being typed in as the texter types them. The benefit of this is if the sender cannot finish the text or hit send, you at least get part of that data stream. The other benefit is true I3 call signaling, and the NENA I3 Standard is what they have been working towards for a number of years. It makes the ALI location information part of the call itself and not really like a side process. That is a project that will take some time, and there is most likely going to be some CPE provisioning that will have to happen as well. This upgrade sets the stage for that future enhancement as well. Also, as an interesting side benefit, they think they have fixed the DTMF issue. If you remember this impacts specifically the language line product where when you typed in your code it would fail and eventually you would get to a live attendant. It caused delays in that process. With the upgrade they think they have fixed that issue and you should be able to just type in your code once and it should immediately be recognized using those touch tones.

There is a Cyber Resilient 911 Symposium in May presented by CISA. They have had these various interoperability type workshops in the past with the 911 Program, the SWIC, etc. This is another iteration of those. This one is held in Kansas City in May and they have also asked a few folks from Scott County to attend. Scott County participated in the cyber assessment process through CISA. Ryan Mulhall from the ICN is attending as well and they just wanted everyone to be aware of the upcoming workshop.


It has been about eight months since Director Benson attended the 911 Council meeting and started talking about changes to surcharge. This discussion is looking towards the next legislative session and obviously with the current \$3 million dollar proposal at the moment this could change in the next couple of days. It is time to start talking about this and what is being presented here is just ideas only. They are trying to build consensus and get input on various ideas and concepts, so they have something next year to take to the legislature, and get out of the current situation that they at the State 911 Program are in. They continue to look at various indicators (they have charts and spreadsheets to show) that they are expending more money that they are taking in at the state program. Blake then talked through the various ideas. He stated the easiest thing would be to ask for a surcharge increase. They have not raised the surcharge statewide since 2013. It is probably a fairly easy sell. However, similar to the

reasoning within the legislature regarding this \$3 million dollars, there is the perception that local 911 budgets are too flush with cash. DeRouchey is aware that there are a lot of opinions within the local community that would counter that. We need to work together on both sides to get things accomplished – raise the surcharge and get the other side of the house in order as well. DeRouchey talked through the different options or ideas that have been presented:



The only suggestion outlined that was not included in the slide deck was a sliding scale, and being able to adjust the surcharge as necessary to raise the funds. This was suggested previously by Chair Rotter. All of these various ideas are percolating, and if you have any strong opinions or thoughts, either here or if you want to reach out individually to Blake you are welcome to have that conversation.

There was a question about the average carryover across the state and DeRouchey also displayed this slide, which he had presented at the recent Iowa NENA Conference. This was from last year's budgets. He will be getting an update on this within the next month or two from the Department of Management. There are three categories that you can put your carryover funds into 1) assigned 2) reserved and 3) unassigned. The folks at the legislature are looking at all three of those combined. So, even if you have something under contract, they are counting that as your carryover surplus. There is a better way to analyze that but remember that if you put it in as unassigned, it says that you don't know what you are going to spend it on. If you look at all three categories the total for the state in carryover funds is \$58 million dollars. The unassigned is much lower, like the \$14-16 million dollar range, which divided by 99 counties is much more reasonable based on the fact that communications equipment is very expensive. It was reiterated that if you are a county with money set aside for a project, reach out to your legislators, and explain why you are holding onto it and how much it is going to cost.



#### <u>Iowa State Interoperable Communications System Board Update (Haley Nichols)</u>

SWIC Haley Nichols gave a quick update and advised they continue to do outreach efforts. They were in Southern Iowa this month and also made a trip to the Lacrosse Wisconsin National Weather Service. The National Weather Service has been interested in getting on ISICS and they have some of their Iowa services outside of the actual state of Iowa. Now that it has been tested, those agencies will work to procure equipment, and begins discussions with Comm Centers and Emergency Management concerning procedures on how to use ISCS for communications. Nichols has directed them to the supervisor groups, emergency managers, and people in our profession.

The REMCDP grant is continuing with good progress in outreach, planning, and procurement. She will keep us updated as that develops.

There are two standards out for public comment and those are open until the 14<sup>th</sup> of this month. The training standard 2.11 and the Travel and Transport standard 1.5.1. If you haven't had a chance to look at those, please do so and if you have anything to add please let them know. There are some substantial changes that the communities made to those standards.

They are in the process of planning a Communications Exercise for Story County that will be June 18<sup>th</sup> – 20<sup>th</sup>. The 19<sup>th</sup> will be a planning day and then the 19<sup>th</sup> and 20<sup>th</sup> are two separate exercise days where participants can get their position task books signed off on. Each day is a day that you can get your task book completed, you would only have to attend one of the days. There is already a robust list of interested parties so sign up right away if you are interested. Also, the Central States COMEX in Joplin is being held in the Fall. Nichols will be attending that and she can get anyone the information if they are unable to attend the one in Story County. Wisconsin is also having a COMEX in the Fall and they have invited Iowa individuals so there is another opportunity to complete your task books if anyone is interested.

Blake mentioned the Cyber Resilient Symposium in May that she will be attending. There is a lot of information concerning Cyber lately, it is a topic that is in the news, and she will be keeping her ear to the ground on that.

Lastly, Nichols offered a thank you to all those in the 911 profession for their service and sacrifice regarding National Public Safety Telecommunicators Week, this next week.
