Blake DeRouchey talked about somewhat of a technical advisory issue first off. It has been an ongoing discussion over the last number of months. It is highly specific and concerns a US Cellular carrier using a Samsung S20 Series phone. They have been able to replicate in a number of locations using multiple call handling systems, that the phone after it rings for 20 seconds will glitch and then continue ringing. This is what the caller experiences. At the PSAP what the call taker experiences is an abandoned call after 20 seconds and then almost immediately a new call is generated that appears as if it is a non-initialized phone. It appears as a 911 call without the correct call back information and like a totally separate call. The call taker now has two calls that are showing on their call taker screen, one is abandoned, and one looks like a new call, but it is really the same caller. If the call taker picks up that second call, they are able to talk to the caller. However, if they try to call back the number that was abandoned, they get the voicemail of the caller because that caller's phone is locked into emergency mode, and it can't accept calls.

A number of months ago he reached out to US Cellular, and they provided a technical description of what is going on in the background. To a point the technical description makes sense, and they get what it is trying to do. They cited NENA call answering standards are for twenty seconds. This has come back up and they have been able to duplicate this test. One thing that they have noticed, and it is even more alarming, is that in some cases when they've run this test is that after twenty seconds it is trying to find another way to connect. They think this is what the phone is trying to do from a technical perspective in the background. In some cases, and they have experienced this is more rural Iowa and more remote locations, those other technical methods do not exist. In this case the caller will be hung up on and meanwhile at the PSAP the call is still ringing. They have reached back out to US Cellular and have recorded all of this. It has been documented and they have put the ball back in their court. They have discussed if this doesn't get more attention, they will turn what they've done over to the Office of Consumer Advocate or their Assistant Attorney General. They will wait and see where that conversation goes from there. They have acknowledged the email Blake sent them

with the video and what the State's next steps are laid out. It is to be determined what they will come back with, and they have also offered to assist with further testing since they have all the contacts for all the PSAPs in the state. In the interim we may want to share this information with our telecommunicators in case they see this weird behavior it could be the device that is being used. Again, it is the US Cellular Samsung S20 Series and this is the video link that shows what happens and explains it: US Cellular Samsung Test.mp4 - Google Drive.

They also have a required annual report that the 911 office submits to the general assembly every year that is due January 15th. They have already submitted that report. He is happy to share that with anyone who is interested and is working on getting that posted to their website as well, so it is there and available for download.

They have sent out a number of reminders on the forms that are due. There are still 63 outstanding expenditure collection forms and 50 outstanding service board membership forms. You can see the list on the slide of who needs to submit those forms yet.



Iowa State Interoperable Communications System Board Update (Haley Nichols)

SWIC Haley Nichols reported that they are currently working on their SCIP review (Statewide Communications Interoperability Plan). Friday the finance committee will meet and then they will have made it through all of their committees. They plan to have a final working day on February 8th, after their regularly scheduled meeting.

Other items of interest included that Wisconsin is planning a Communications Leader train the trainer training course. They have opened the opportunity up to students outside of their state and specifically to Iowa. The class will not be scheduled until the perspective students are identified and they can confirm that they will meet their numbers. If this is of interest to you, and you have the prerequisites (those are listed on page 50 of the technical assistance guide), get in touch with her and she will put you in touch with Eric Benson who is the Deputy SWIC responsible for training and exercise in Wisconsin. It is a good opportunity, and those courses don't come around all that often. Often there is a virtual option and an in-person option, and she was not exactly sure what Wisconsin was thinking for this offering.

The Incident Tactical Dispatcher (INTD) course that will be held the week of January 30th in West Des Moines is open for registration and there has been a lot of interest. There are only four spots left until the maximum attendance is met. If your agency has people interested, she requests that you get the prerequisites completed and fill out that registration form.

In the meeting following this one, the ISICS Board will hear the request for a COML (Communications Unit Leader) and a COMMEX (an exercise where position task books can get filled out). They are putting those TA requests in for 2024. She will update the group next month to see if those requests were approved.

Chris Maiers CISA Update

Maiers began by letting everyone know that they have discovered a confirmed compromise with one of the national interoperability encryption keys. CISA is now advising all public safety agencies that may be using this encryption key to discontinue its use because it can no longer be considered secure.
