## FEMA PUBLIC NOTICE OF AVAILABILITY DRAFT ENVIRONMENTAL ASSESSMENT FOR MANUFACTURED HOUSING UNIT GROUP SITE KNOWN AS THE ROCK RIDGE GROUP HOUSING SITE ROCK VALLEY, IOWA Unique NEPA ID: EAXX-024-70-000-1725992586

The Federal Emergency Management Agency (FEMA) hereby gives notice to the public of its intent to construct a manufactured home park development for use as a temporary group housing site. FEMA has prepared a draft Environmental Assessment (EA) for the proposed installation of Manufactured Housing Units (MHU) at the Rock Ridge Group Housing Site. The site may provide suitable temporary housing for individuals and households displaced by the severe storms, flooding, and tornadoes that occurred from June 16 to July 23, 2024, and resulted in FEMA-4796-DR-IA signed by the President on June 24, 2024.

The proposed action includes developing an approximately 31.41-acre site to install 66 MHUs, along with infrastructure, such as water and sewer lines, for up to 84 MHUs. This will be located at the eastern end of Rock Ridge Road, in Rock Valley, Sioux County, IA (GPS: 43.202335, -96.252663). Activities may include, where necessary, site clearing, grading, road construction, the placement of utilities (electricity, telephones, water, and sewer), and the transport and installation of manufactured homes to the site. This group housing site will be operational for up to 18 months, but the improvements will remain indefinitely.

In accordance with the National Environmental Policy Act of 1969 (NEPA), the Council on Environmental Quality (CEQ) regulations implementing NEPA (40 Code of Federal Regulations Parts 1500-1508), FEMA's Instruction 108-1-1 for implementing NEPA, the National Historic Preservation Act, 44 CFR Part 9, Executive Orders 11988 Floodplain Management, 11990 Wetlands Protection, and 12898 Environmental Justice. FEMA has prepared a draft EA. An alternatives analysis was performed, which included the evaluation of the potential impacts of the proposed action on the human and natural environment, and the No Action alternative. The draft EA summarizes the purpose and need, site selection process, affected environment, and potential environmental consequences associated with the proposed action and no-action alternatives.
