Program Manager Report – ILEA Update

Blake DeRouchey began his report with a timeline for the relocation of the data centers. Idependently of each other, both provided notice that the buildings are closing and will no longer be used as data centers. The West Des Moines location is the most immediate need and it will be moving to Raleigh, NC into a national facility there owned and operated by Comtech. A positive is that a lot of the wireless providers are already in that facility. That will make the

transition a little easier and the timeline is around the next 12 months. The West Des Moines facility is closing the end of June, so they are already working towards that.

The other data center which is located in Davenport is a little bit less time sensitive. It will be moving to a vendor agnostic facility in Council Bluffs in the next 18-24 months. The approach that they are taking is one national data center located out of state, and one remains instate. In having one instate it protects us from larger national issues, but then also having one out of state, it is a little bit faster and a little less expensive to go into a national facility. They have not given the final thumbs up on the acceptance of that plan yet, but that should come anytime now. This is the proposal that is likely to be accepted here in the upcoming days.

When DeRouchey returned from NASNA last month, he thought the findings were a bit interesting. The FCC over the last few years has tightened up their rules on caller location accuracy. This, in conjunction with implementing GIS and geospatial routing within the state of Iowa, compelled him to take a look at what that meant for transfers within the state. Ideally those two things, one implemented by the carrier and one by them, should make for more accurate call routing to PSAPs. He compared quarter 3 of this fiscal year (2025) to previous FYQ3 of 2018 and discussed his findings. In that time there was a 12% increase in overall call volume, however in that time there was a decrease in call transfers. He split those findings into two categories, one being total operational transfers, and routing transfers such as transferring to a neighboring PSAP. DeRouchey wanted to show this progression of transfers over time.

Over the last 12-18 months, they have worked with a core group of folks that were interested in establishing a Telecommunicator Emergency Response Team (TERT) here in the state of Iowa. Prior to this collaboration there was a really loose agreement with the group, they recognized that the other existed, and if there was a need for a TERT deployment they would communicate with each other. They realized that in the event of an instate or out of state deployment, they needed more documentation. They needed to talk through issues like salary, benefits, and backfill for the TERT's agency. They have accomplished officially declaring them an emergency response team. Iowa Code 29C states that their department has the ability to raise, train, and deploy emergency response teams. These can be search and rescue teams, Haz-Mat teams, and incident management teams. They have five agreements signed so far with both employers and individuals that allows them in times of disaster, both instate and out of state, to deploy the TERT team. It is optional and these folks have shown an interest and willingness to deploy, if available. This will help identify them as an agent of the state and provides for reimbursement. They are looking to grow that team so if there is interest please reach out to DeRouchey or Brian Sellner with Westcom. Also a clarification, the reimbursement is not done through surcharge dollars. It's through the state general fund, using economic emergency funds. TERT teams can be deployed faster now with these things in line, prior to a request coming in.

A number of years ago the Governor put out executive order 10 (EO-10) which directed all state agencies to go through a process to rescind, redraft, and reapprove all of the agency rules. Each agency was assigned a certain calendar year, and they are in about year three of EO-10. This is their department's calendar year to work on this. They have already gone through the process for about six of their agency rules. They waited towards the end of the year for Chapter 10, which governs 911. DeRouchey has started to work through that, and that rule is about 14-pages long. There are a number of steps along the way for public engagement. There is regulatory analysis, public comment, and a public hearing phase. The next step is the notice of intended action and again, there is a period for public comment and public hearings for that. As they go through this process he would anticipate some feedback from this 911 community. They will ultimately arrive at a clean, brand-new version of Chapter 10 that is hopefully modernized, removes restrictive terms, and doesn't repeat Chapter 34A in it anymore.

DeRouchey is just introducing it today and there will be more to come in the next couple of months before the end of the calendar year.

There was a brief update on SF 659 and it's implementation. There are no changes to report but they wanted to remind everyone of the process where they would like to get MOUs in place with 911 Service Boards. It allows them to withhold the appropriate amount of funding on the front end versus a process where they remit surcharge payments, invoice local jurisdictions, and then you cut them back a check. It save on the administrative overhead on the entire process. To this point they have 18 people interested in signing MOUs, and they anticipate sending those MOUs out to them by the end of the week. If you are interested, you can indicate so by email or scan the QR code provided here on the slide. It is not the MOU itself, but is like raising your hand to say you are interested and they would follow up by sending you the MOU via email for signatures and processing.

DeRouchey provided the upcoming training schedule for the 40-hour basic telecommunicator classes that he received from Anna Voss. There is one being held next week at ILEA with 30 registrants from July 14-18th. There are two more on the calendar, in September at ISP Post 7 in Ft. Dodge, and in November at Oelwein PD.






