

## **Funding Opportunity Announcement for 2024 Nonprofit Security Grant Program (NSGP)**

Iowa's Department of Homeland Security and Emergency Management (HSEMD) has opened the application period for the 2024 Nonprofit Security Grant Program (NSGP) sub-grant. As detailed on the chart at the end of this document, **the deadline for submission of a Notice of Interest (NOI) is Wednesday, November 8, 2023 with the application deadline of Thursday, January 11, 2024.**

Please note: The Nonprofit Security Grant Program (NSGP) is a competitive application. It is a separate funding source and application process from the Homeland Security Grant (HSGP) and the School Safety Improvement Grant.

NSGP is funded by the U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA). The federal appropriations and state allocations have not yet been announced. HSEMD is moving forward with the sub-grant application phase per FEMA's recommendation for states to be planning projects for this grant.

### **Iowa sub-grants for NSGP – State (NSGP-S):**

Nonprofit Security Grant Program (NSGP) provides funding support for physical security enhancements and target hardening activities to eligible nonprofit organizations. This program makes funding available for vulnerabilities that could be exploited in an active assailant/armed intruder scenario.

NSGP-S eligible applicants include nonprofit organizations that are:

1. Determined to be at high risk of a terrorist attack by the Secretary of Homeland Security, and
2. Described under section 501(c)(3) of the Internal Revenue Code of 1986 (IRC) and exempt from tax under section 501(a) of such code; refer to links below for additional information:

**Note:** The Internal Revenue Service (IRS) does not require certain organizations such as churches, mosques, and synagogues to apply for and receive a recognition of exemption under section 501(c)(3) of the IRC. Such organizations are automatically exempt if they meet the requirements of section 501(c)(3). These organizations are not required to provide recognition of exemption. For organizations that the IRS requires to apply for and receive a recognition of exemption under 501(c)(3), the state may or may not require recognition of exemption, as long as the method chosen is applied consistently.

### **Vulnerability Assessment**

Successful applicants to this funding opportunity must submit the following:

1. Verification of current vulnerability assessment completed for each occupied building for which funds are being sought.
  - a. Please note that any vulnerability assessment completed prior to the 2024 application cannot be more than 3 years old. Vulnerability assessments must include defined vulnerabilities and options for consideration to mitigate vulnerabilities.
  - b. A vulnerability assessment must be completed by one of the three options listed below:
    1. Assessment by Law Enforcement
    2. Assessment by Vulnerability Assessment Services Providers
    3. Assessment by HSEMD
  - c. A vulnerability assessment completed utilizing a self-assessment tool or vulnerability assessment service provider other than the HSEMD and/or HSEMD contracted 3<sup>rd</sup> party entity will be required to have an official letter from local law enforcement validating the vulnerabilities and options for consideration identified from the self-assessment.

A copy of a valid vulnerability assessment and/or other documentation, as outlined above, must be submitted as part of the completed NSGP application.

### **Additional Information**

Interested applicants must apply through HSEMD's electronic grant management system. This system is referred to as EMGrants. Access the system through the website <https://my.iowa.homelandsecurity.org>.
