Introductions

Chair Rob Rotter welcomed everyone. A roll call was conducted by Secretary Cara Sorrells of the board members in attendance. A quorum was established, and the meeting continued.

Approve the Agenda

Chair Rob Rotter asked for a motion to approve the agenda as presented. Motion by Richard Pierce to approve the agenda. Seconded by Cara Sorrells. All ayes. Passed.

Approve the Minutes

Chair Rob Rotter asked for a motion to approve the previous meeting minutes. Motion by Richard Pierce to approve the minutes. Seconded by George Griffith to approve the minutes of October 12th, 2023. All ayes. Passed.

State of Iowa Administrator Reports (Blake DeRouchey)

Program Manager Report

Blake DeRouchey apologized for the technical difficulties with the meeting link this morning. The first thing he presented was the quarterly report and there was nothing of note on the PSAP payments. They are not withholding any funding for late forms or anything like that. On the expenditure report the amount of wireless surcharge received was 7.8 million dollars. They accrued more interest on the fund, due to high interest rates, and it was \$84,000 dollars. The prepaid card revenue was normal at \$576,000 dollars. The first quarter of the year is when the funding for management and administration of the program come out and that is \$300,000 dollars. The wireless cost recovery is blank due to the invoice literally getting lost in the mail. You will see a double payment coming out of the second quarterly expenditure report. After the recurring network costs from the various vendors that make the 911 system work, 60% of PSAP funding comes out to just over \$5 million dollars. Also, similar to the first quarter of the last fiscal year they did have to dip into the surplus in order to pay all of the bills on the front end of the fund. That number is \$406,000 dollars and all indications now, and we saw it last year as well, are that we are going to have to do something related to surcharge before too long.

A couple of months ago Director John Benson was in attendance and he brought this surcharge issue up as well. Nothing has changed from their perspective and the time frame to do something or take action for them would be next 2025 legislative session, not the one that starts here in a couple months. There may be legislative interest in doing something with it this year, that is not necessarily coming from them, but they would obviously participate in that discussion and make sure whatever happens looks ahead to keep the fund solvent. They have started having some conversations with folks, a brainstorming group that includes a couple of members from the Council and the 911/PSAP Community, that understand the fund. This is to talk about different scenarios or formulas or ways that the fund could work to solve many problems. It is unknown which direction legislators might take this session if that momentum starts to build. They just want to be ready for multiple different scenarios and for that discussion. They are running a number of different calculations and if anyone has any good ideas or is interested in participating, please let Blake know. Participation is welcome and ideas are welcome. If you have any questions about the calculations they are running you are also welcome to reach out. Nothing is set in stone they just want to be ready for the conversation.

This summer they implemented ECRF, a core function of a NextGen 911 system and a part of the NENA i3 Standard. It is geospatial routing and uses all the GIS data that we have been working on. Instead of using towers and cell sector faces they use GIS data. Blake had Comtech pull some information to show that it works. They found that for the month of August 1,728 calls routed more correctly using the geospatial methodology.

They are looking to the next phases of the 988/911 pilot, and they are looking at Linn County next. Linn County has three PSAPs, and they already have three PSAPs on the pilot, so it is essentially doubling that by adding just one county. That will be the next step and after that they will look at broader adoption and expansion for those that are ready. If you indicated on the survey that you were interested, they will be in touch shortly after Linn County goes live.

Awhile ago the 911 Program began the Cyber Assessment through CISA. They had their out brief for that earlier this week and the written report is soon to follow. They will be sending it out and posting it to their website. The report is very good and there were about three findings

or recommendations, and they are fairly minimal. They will get that out to the community and, where they can, try to implement some changes or best practices.



The underlined part is the suggested phrasing to again put some guardrails or some language in the policy to acknowledge EMD funding and some of the concerns that were addressed last month.

<u>Iowa State Interoperable Communications System Board Update (Haley Nichols)</u>

SWIC Haley Nichols reported that the COMU suite is done for 2023, they finalized with the COMT course at ILEA in Johnston a week or two ago. Seven students completed that course and thanks to Director Carney for allowing them to host the course. Also, thanks to the DPS team for making the mobile command and central STR trailer available. It was very beneficial to the group. Looking forward to next year for courses there is already an INTD course scheduled January 30th, 2024, in West Des Moines. The registration for that will go live hopefully next week. It is a popular class so if you have interest, please sign up early.

They deployed 20 cache radios to Delaware County for a training exercise they were involved in. This is a reminder that there are resources available for deployment in case your agency is involved in something and needs those. Also, as a reminder, the ISICS Board is reviewing and revising the SCIP (Statewide Communication Interoperability Plan) for the next 1-3 years. Those meetings have begun, and each committee is having a two-hour webinar. Next week is the FirstNet and the user group committee, which both of those are really beneficial to the whole process. The more people that join, the better to get those comments and ideas flowing. It is a brainstorming session so that when they move into their workshop on the 8^{th} (which will follow the regularly scheduled board meeting here in Adel) they can pull it all together and come up with a document.

The RIC meetings happen monthly so that means each region of the state has a monthly meeting where you can join and share your experiences with the ISICS system. They highly

recommend your participation and are interested in hearing from the PSAP or Comm's side of things. They also have trainings available online on the ISICS website pertaining to the use of the system. Currently there is a pursuit module and the StatusBoard training and those are available 24 hours a day for people to take. Remind your dispatchers that it is free, easy training available if they want to take a look at it. They are updated on a regular basis.

Chris Maiers CISA Update

Chris Maiers complimented the State of Iowa after Blake mentioned the Cybersecurity Assessment. Historically they have done a very good job in making sure that the infrastructure they have follows as many best practices when it comes to security protocols as possible. 

Information Sharing

Shanna Krogmeier had one item. They are reintroducing the 911 Saves Act on the federal level. It was announced yesterday so if anybody wants to voice their support for that they can go to the NENA website and do that. There is a simple form to fill out that gets sent out to your state legislators. The 911 Saves Act is reclassifying 911 telecommunicators as first responders on a federal level, they are currently classified as secretaries.

New Business

We have utilized virtual participation on the Council much more since COVID. We do still have to deal with the fact that many people do travel here for it. It is pretty standard with what we have been doing, but the advantage is now that we have a lot more virtual participation so the likelihood of being all-out cancelled is quite a bit less than it once was.
